



MINORS – WAIVER RELEASE AND INDEMNIFICATION AGREEMENT FOR ALL STUDENTS

I am the parent or guardian of a child (or children) who participates in IntelliBricks STEM Enrichment Classes.

I am fully aware that my child's (or children's) participation in this Program is totally voluntary. In consideration of the IntelliBricks. I agree to permit my son(s)/daughter(s) to participate in the aforementioned lessons/activities, the receipt and sufficiency in which consideration is hereby acknowledged, I agree as follows:

I, individually, and on behalf of my minor child (or children) and our respective heirs, successors, assigns and personal representatives, hereby release, acquit and forever discharge the IntelliBricks and their teachers and teacher aides, students, parent volunteers, agents, board members, officers, trustees and representatives (in their official and individual capacities) from any and all liability whatsoever for any and all damages, losses or injuries, including death, to persons or property or both, including but not limited to any claims, demands, actions, causes of action, damages, costs, expenses and attorney's fees, which arise out of, during or in connection with my child's (or children's) participation in the aforementioned lessons and activities, including but not limited to any damages, losses, or injuries to persons or property or both, which may be sustained or suffered by my child or any person in connection with my child's (or children's) association with, or participation in, activities at, sponsored by, or arising out of the schools activities and meetings.

I understand that **IntelliBricks may photograph my child** (or children) participating in an activity from time to time. I understand and agree that all photos will **become the property of the IntelliBricks** and will not be returned. I hereby irrevocably authorize the IntelliBricks to edit, alter, copy, exhibit, publish, or distribute these photos for any lawful purpose. In addition, I waive any right to inspect or approve the finished product wherein my child's likeness appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of the photo.

I understand that children **cannot take home any Lego or creations.**

Late Pick Up Policy: I understand that I need to pick up my child on scheduled pick-up time. I agree to pay a **late charge of \$1.00 per minute** after a **15-minute grace period**, in the event I come late for pick-up. I understand that only authorized adults can pick up the child from the class room. If there is **any change** in the pickup procedure, I will **notify IntelliBricks before** the class starts.

Refund Policy: I understand that all refunds have a processing fee of **\$15 per student per session**. After the class starts refunds will be granted on a case by case basis.

Missed Classes: I understand that **no refunds** will be issued **for missed classes**. If my child does **miss one and only one** of IntelliBricks' weekly classes **during a 4 to 6-week session**; I can request a pro-rated credit for future use of IntelliBricks Classes **after the session has concluded**.

I agree that this Waiver, Release and Indemnification Agreement is intended to be as broad and inclusive as permitted by the laws of the state of California and/or Placer County, and if any portion hereof is held invalid, it is agreed that the balance hereof shall, notwithstanding, continue in full legal force and effect.

In signing this Waiver, Release and Indemnification Agreement, I hereby acknowledge and represent that I have read this entire document, that I understand its terms and provision, that I understand it affects my legal rights and those of my child (or children), that it is a binding Agreement, and that I have signed it knowingly and voluntarily.
