

Enrollment Agreement:

My child has my permission to attend camp/class/parties, under the supervision of the Funky Divas & Dudes LLC. I agree to pay all tuition and fees set forth for Funky Divas & Dudes. Any questions I have about Funky Divas & Dudes Camp/Classes have been answered to my satisfaction.

I understand the Behavior Policy: Cooperative behavior makes enrichment programs and camps fun and safe for all. If a student is seriously disruptive or unsafe during class, the first time is a warning and parents are contacted. The second time, the student may not continue with the program, with no refund. I have confirmed that my student is motivated to take the registered club(s) in order to create a good experience for all involved. I will inform the instructor if my child needs reasonable accommodations in order to participate in activities.

In the event of a medical emergency, we will call 911 and contact parent(s)/guardian(s). On behalf of my child(ren) I voluntarily assume all risks of injury, loss, or damage that may be sustained and release and discharge Funky Divas & Dudes LLC, its officers, staff and employees from all loss or damage and from any claim or demand on account of injury or death. I agree to hold harmless, indemnify and defend Funky Divas & Dudes LLC, its officers, staff and employees from any and all liability, claims, expenses, demands, fees, judgments and/or damages arising directly or indirectly from my child(ren)'s participation in programs or at any time my child(ren) is on the premises of or premises used by Funky Divas & Dudes, save and except claims arising out of the sole willful misconduct of Funky Divas & Dudes. I will reimburse Funky Divas & Dudes, it's officers, staff, employees and agents for all expenses including reasonable attorney fees for all such claims made. I hereby release Funky Divas & Dudes LLC, Dana Marie Lazzareschi & Kelly Richardson of any injury claims resulting from my child participating in the programs. Funky Divas & Dudes LLC may use my child's photograph/ likeness in promotional materials, unless specified otherwise.

Cancellation/Refund Policy:

Dance Classes (in-person): Classes are subject to cancellation if minimum enrollment is not met. Buyers will be notified via email and refunded in full. After the second class, no refunds will be given. If your spot fulfills the minimum requirement of students to run a class, there are no refunds at all. There are no partial refunds or make-ups for missed classes.

Dance Classes (virtual): Classes are subject to cancellation if minimum enrollment is not met. Buyers will be notified via email and refunded in full. There are no refunds less than one week before the class date. There are no partial refunds or make-ups for missed classes.

Summer Camps (virtual & in-person): Classes are subject to cancellation if minimum enrollment is not met. Buyers will be notified via email and refunded in full. Refunds may be given before May 31. After May 31, there are no refunds or makeup days.

Spring Break/Winter Camps (virtual & in-person): Classes are subject to cancellation if minimum enrollment is not met. Buyers will be notified via email and refunded in full. There are no refunds less than one week before the class date. There are no partial refunds or make-ups for missed classes.

Parties (virtual & in-person): I understand there are no refunds on deposits for party cancellations or rescheduled parties. Deposits are held to reserve the date and start preparing for the party in advance. In the event you need to cancel your party, the remaining balance will also be due, unless the party is cancelled at least 2 weeks prior to your party date. Rescheduled parties require a new deposit.
