CLASS POLICIES/EMAIL CONSENT

Enrollment: Classes are taught using the school's existing classroom designations, unless groups are otherwise organized in partnership between the school and Teeny Tumblers. **Tuition is non-refundable for any reason.**

Class Cancellations/Make-up Classes: Class may be cancelled due to coach illness, inclement weather, or some other unforeseen schedule conflict. **Make-up classes are provided at Teeny Tumblers sole discretion**, and if a makeup class is not provided a credit for the prorated value of the missed class will be awarded to your account. Classes will be scheduled around school-wide holidays and closures shared at least 90 days in advance. School cancellations and closures not provided 90 days in advance will not be offered a make-up class or credit.

Behavior Policy: Students who display disruptive behavior during class including but not limited to ignoring the coach, repeatedly disobeying instructions, or acting in a way that is unsafe for themselves or others, may be asked at the coach's discretion to check in with their school staff for behavior management.

Parent Observation and Behavior: Parents' access to their child's classroom is first determined by the individual School's policy, then (as allowed) follows our policy: The best way to observe classes is by viewing the photos shared by the school via their standard communication system, app, email list, etc. Parents are welcome to observe classes, however viewing indirectly (for example, through a window) or from a designated viewing area is requested as entering the room may distract your child and make it harder for them to focus on the lesson or transition back into their day. Parents must also conduct themselves in a polite, kind, and supportive manner. Any inappropriate behavior by parents including but not limited to unsportsmanlike behavior, shouting, threatening movements or speech, damaging property, etc. is grounds for removal from the program for both parent and child(ren) without refund.

Dress Code: Gymnastics requires great range of movement, so children's clothes should be easy to move in such as sweatpants, leggings, etc.
