

## **RELEASE OF LIABILITY AND PHOTOGRAPHY RELEASE**

I, the undersigned, am the parent/legal guardian of the minor participant. I affirm that the participant is a minor, and that I have the legal authority to sign this agreement on their behalf. I acknowledge that I have had the opportunity to consult legal counsel prior to signing.

In consideration of the minor's participation in GrowFit activities, I, for myself, the minor participant, and our respective heirs, assignees, and successors, release and hold harmless GrowFit, its officers, employees, volunteers, agents, and others officially connected with its activities, from any liability, damages, losses, illnesses, injuries, legal entanglements, imprisonment, death, or loss of money that may arise from participation in these activities.

**ASSUMPTION OF RISK:** I understand and accept the risks of participation, including, but not limited to, sprained muscles, ligaments, broken bones, fatigue, and even death. I assert that the minor participant is in sufficient physical condition for the level of physical activity potentially involved in the events.

**AGREEMENT TO INFORM GROWFIT:** I agree to inform GrowFit of any medical conditions, allergies, or special needs that my minor child has, and I will promptly update this information if it changes. I acknowledge that failure to disclose relevant medical information may jeopardize my child's safety during participation in the Programs.

**CONSENT FOR MEDICAL TREATMENT:** I authorize GrowFit and its representatives to seek and consent to medical treatment for my minor child in the event of injury, illness, or other emergency during participation in the Programs. I understand that GrowFit does not provide medical coverage, and that I am responsible for any medical or other costs arising from the minor participant's participation. I affirm that the minor participant is covered by medical insurance. I understand that reasonable efforts will be made to contact me or the emergency contact listed below in the event of such a situation.

**AGREEMENT TO FOLLOW PROGRAM RULES:** I, as the parent or legal guardian, agree that my minor child will abide by all rules and guidelines established by GrowFit for participation in the Programs. I understand that failure to comply with these rules may result in my child's removal from the Programs without refund.

**PHOTOGRAPHY AND MEDIA RELEASE:** I grant GrowFit the worldwide right to photograph or film the minor participant, and to use the participant's likeness in any and all publications, educational materials, research, advertising, news media, video, and worldwide web materials, understanding that these materials will remain the sole property of GrowFit.

SEVERABILITY: If any provision of this Release of Liability Waiver is found to be unenforceable or invalid, that provision shall be severed from this agreement, and the remainder of the agreement shall remain in full force and effect.

INDEMNIFICATION: I agree to indemnify and hold harmless GrowFit against any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities arising out of or connected with the minor participant's involvement in GrowFit activities.

This Agreement is governed by the laws of the State of California and is intended to be as broad and inclusive as is permitted by those laws. By signing this form, I am releasing all liability and granting all permissions as described above.

I have read this Release of Liability Waiver carefully and understand its contents. I am aware that by signing this document, I am waiving certain legal rights on behalf of myself and my minor child. I sign this document voluntarily and without any duress.
