Sea Crest School Summer Camp Participation and Waiver Agreement

I, the parent and/or guardian ("Parent") hereby enroll my child ("Camper") in Sea Crest School's ("School") 2025 Summer Camp Program ("Camp Program") as stated herein, on the terms and conditions set forth below.

1. **Voluntary Participation.** Parent gives their consent and permission for Camper to participate in the Camp Program. Parent understands that Camper's participation in the Camp Program is completely voluntary and subject to parental consent.
2. **Description of Activities.** Camp Program will take place at School's campus located at 901 Arnold Way, Half Moon Bay, CA, 94019. Camp Program may include but is not limited to activities such as: arts and crafts, skateboarding (including minor tricks, ramps), use of hot glue guns, painting, playing musical instruments, riding bikes/scooters, climbing on playground equipment, use of an inflatable bounce house or obstacle course, building, cooking projects (e.g., use of knives, hot plate, griddle), STEAM projects and science experiments (e.g., rockets made from canisters and alka seltzer, mentos and coke explosions, watermelon rubber band explosions), relay races, obstacle courses (e.g., crawling through tunnels, jumping up and on objects, balance beams etc.), riding on scooter boards, water play (e.g., using a slip and slide down the hill, inflatable water slide, water squirters, running through sprinklers, throwing water balloons etc.), group games and sports, dancing, singing, Nerf blaster games, tag, and glow in the dark art.
3. **Acknowledgement and Assumption of Risk.** Parent acknowledges and understands the risks of accident, illness, serious injury, permanent disability, and even death from participation in Camp Program. Parent understands and acknowledges there are risks involved with participation in Camp Program, which include, but are not limited to, minor injuries such as scratches, bruises, and sprains; illness or disease, including exposure to infectious diseases; emotional trauma; heat-related illnesses; major injuries such as joint or back injuries, eye damage, injuries to internal organs, brain injuries and concussions, injuries to joints, ligaments or muscles or broken bones; and catastrophic or life-threatening injuries.

Additional risks inherent in participation of some Camp Program activities may include: (1) injuries from participation in sports and recreational activities, including contact sports, which may include injuries from running, jumping, sliding, and diving on an indoor or outdoor sport court, injuries from contact with other players, or other recreational and sports equipment; (2) injuries from participation in relay races and obstacle courses, which may include injuries from falling and running into objects or other students; (3) injuries from dance and movement activities, which may include injuries from strenuous extensions of strength using various muscle groups, injuries caused by failing to properly and efficiently warm up before dancing, injuries caused by contact with objects near or on dance areas, or other dancers or participants, or injuries from falls; (4) injuries from cooking activities, which may include burns, cuts, or scrapes; (5) injuries from water play activities, including injuries related to falling and bumping into other campers while going down a water slide or slip and slide, and injuries related to being submerged in water, including drowning; (6) injuries related to participation in arts and crafts projects, which may include cuts and scrapes from use of scissors, hot glue guns, knives, and other art tools; and (7) injuries related to participation in science experiments and projects, including injuries from exposure to explosive combinations of materials and liquids.

Parent understands these injuries or outcomes may arise from Camper or other's action, inaction, or negligence.

Parent assumes liability and responsibility for any risks associated with Camper's participation in any Camp Program session(s), whether described in this Agreement, known or unknown, inherent or otherwise. The School cannot foresee every possible contingency or completely eliminate all risk. Parent has had opportunities to discuss the Camp Program activities with the School.

4. **Release of Liability.** Parent, on behalf of their family and their child, hereby fully and forever discharge and release the School, its officers, trustees, directors, employees, agents, representatives, insurers and volunteers ("Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever, including, but not limited to, claims for injury or death to persons, emotional distress, property damage or wrongful death arising out of or in any way relating to Camper's participation in Camp Program, except to the extent caused by the gross negligence or intentional misconduct of the School. This release extends to any instruction or supervision related to the Camp Program on the part

of the Released Parties as well as potential exposure to infectious diseases on the School's premises or during Camp Program activities. It is the intent of this Agreement to relieve the Released Parties from negligence to the greatest extent permitted by law.

Parent authorizes the use of Camper's image, likeness, recordings and artwork in any and all School publications or promotions, whatever the medium, without compensation.

5. **Agreement to Indemnify.** To the fullest extent provided by law, Parent agrees to indemnify and hold the School and its officers, trustees, employees, volunteers, staff and agents harmless from any and all claims, damages, expenses, and costs of any and all injuries or damages arising from Camper's or Parent's negligent, intentional or other conduct related to Camper's attendance and participation in the Camp Program, from any cause whatsoever, except to the extent caused by the gross negligence or willful misconduct of the School.
6. **Compliance with Camp Program Rules.** Parent agrees that, by entering into this Agreement, Parent, family and Camper agree to accept and abide School rules, regulations, policies and standards. Parent understands that the Camper's enrollment is contingent upon the Camper's compliance with Camp Program rules, and satisfactory behavior. The School reserves the right to remove a camper at any time if, in the sole discretion of the Camp Program Director, that camper's conduct, or influence on or off campus are not in keeping with the School's philosophy, educational program, rules, regulations, policies, standards, or if Camper, Parent, or family fail to comply with School protocols.
7. **Disclosure of Medical Information and Consent to Treat.** Parent acknowledges that it is their responsibility to inform the School of any medical condition, whether temporary or not, which affects the Camper's ability to participate in the Camp Program activities. Parent consents to any of the staff, employees, and representatives of the School administering or consenting to the administration of such emergency medical care to the Camper as such person(s) deems appropriate under the circumstances. Parent understands that the School does not carry or maintain health, medical or disability insurance coverage for Camper, and Parent therefore agrees to assume the responsibility for such insurance coverage for Camper and to pay all costs of medical care and services provided to Camper as a result of or while participating in the Camp Program.
8. **Integration Clause.** This Agreement, represents the entire and integrated agreement between the School and Parent related to the subject matter of this Agreement and supersedes all prior negotiations, representations or agreements, either written or oral regarding the subject matter of this Agreement.
9. **Severability.** If any term or provision hereof is invalid for any reason whatsoever, that provision shall be severed and shall not affect the validity of the remainder of the Agreement.
